Individuals, trade associations, electric utilities, manufacturing companies, industrial companies, municipalities, counties, businesses, brokers, and transportation companies that are or have the potential to be regulated by any federal, state, and/or local environmental or transportation law.

• What previous experiences, prior to your work at Balch, influence your practice?

- CERCLA/RCRA Strategy: Assist clients in understanding, avoiding and/or minimizing potential CERCLA
 and RCRA liabilities associated with the lease or purchase of properties, including evaluation of risks
